

MINUTES OF THE JUNE SESSION
of
THE SIMCOE COUNTY COUNCIL, 1931.

FIRST DAY.

Council Chamber, Barrie,
June 15th.1931.

The Council met pursuant to the adjournment at the January Session.

The Warden in the Chair.

All the Members present, except Councillors McLeod and Stephens.

The Minutes of the last Meeting of the January Session having been printed and distributed, were taken as read.

The Warden addressed the Members and welcomed them to the June Session.

He gave a hearty welcome to the new Reeve of Port McNicoll, Mr. Robert W. Smith.

He extended to Judge Holmes a welcome to the County of Simcoe.

He knew that the customary harmony and good fellowship which is characteristic, would exist as usual between all Members in transacting the business which would be presented to them from time to time.

On extending the welcome to His Honour Judge Holmes, he hoped he would find pleasure in the performance of his judicial duties and could assure him of the co-operation of the citizens of the County.

He referred to the bereavement to Councillor Tessier, Reeve of Penetanguishene, and of Governor Jardine of the House of Refuge, in the death of their fathers, and extended to them his own sympathy and that of the Members of the County Council.

He stated that satisfactory progress was being made with the pavement in the Village of Victoria Harbour, and that a good job was being done, and he expected that the pavement would be officially opened on Thursday evening of this week.

That tenders have been accepted for the pavement authorized by the Council in the Village of Beeton, and that operations would commence in the near future.

The Department of Public Highways have consented to keep the expenditure on the Provincial Highways, in the County, within an amount acceptable to the County Council, but contracts had already been let for paving from Barrie to Midland on Highway No.27, and from East Oro to Orillia, on Highway No.11.

These Payments will have to be taken care of together with the maintenance of the Provincial Highways in next year's levy.

He referred to the Annual dinner of the officers of the Simcoe Foresters at which Captain MacDonnell requested him to convey to the Members of the Council the thanks and appreciation of himself and the officers for their many kindnesses.

He had attended on Sunday, May the 17th, the unveiling of a memorial window and tablet in Trinity Church, Barrie. The window was to the memory of the late A.E.H. Creswicke and the tablet in memory of the late Warden H.H. Creswicke, who accidentally met his death in September 1930.

He had been over the County Roads with the County Road Committee and had found the system, as a whole, in fair condition, and with the ease of the large and improved maintainers he was sure the roads would at all times be in good condition for travel.

He congratulated Councillor Morley, Reeve of Collingwood, on his promotion, by being appointed a King's Counsel, a distinction that was merited.

He also congratulated the First Ontario Co-Operative Packers of Ontario Ltd., on the erection and operation of their new packing plant, and he wished them success in their enterprise, as it would be a great benefit to this County, and felt sure such plants would be erected in other parts of the Dominion.

He trusted that the Council would have a pleasant and profitable session.




